### State Board of Community Colleges to Meet

RALEIGH – The State Board of Community Colleges will hold its regularly scheduled monthly meeting Thursday and Friday, March 18 and 19, 2010. The meeting will begin Thursday at 12 p.m. with an issues luncheon and a presentation titled, “SuccessNC and the Commission on the Future: Moving our Community Colleges Forward.”

Committee meetings begin at 1:30 p.m. Items before the Policy Committee include a vote to amend the rule, [23 N.C.A.C. 02C .0301 “Admission to Colleges.”](#) In response to the state’s growing aerospace industry, the Program Services Committee will consider the approval of a new curriculum program, Aerostructure Manufacturing and Repair Technology. The Finance and Capital Needs Committee is expected to take action on the allocation of funds allowing Pamlico Community College to join its fellow colleges in offering the Career Readiness Certification program.

The full Board will convene Friday at 9 a.m. All meetings take place in the Caswell Building at 200 W Jones St. in Raleigh.

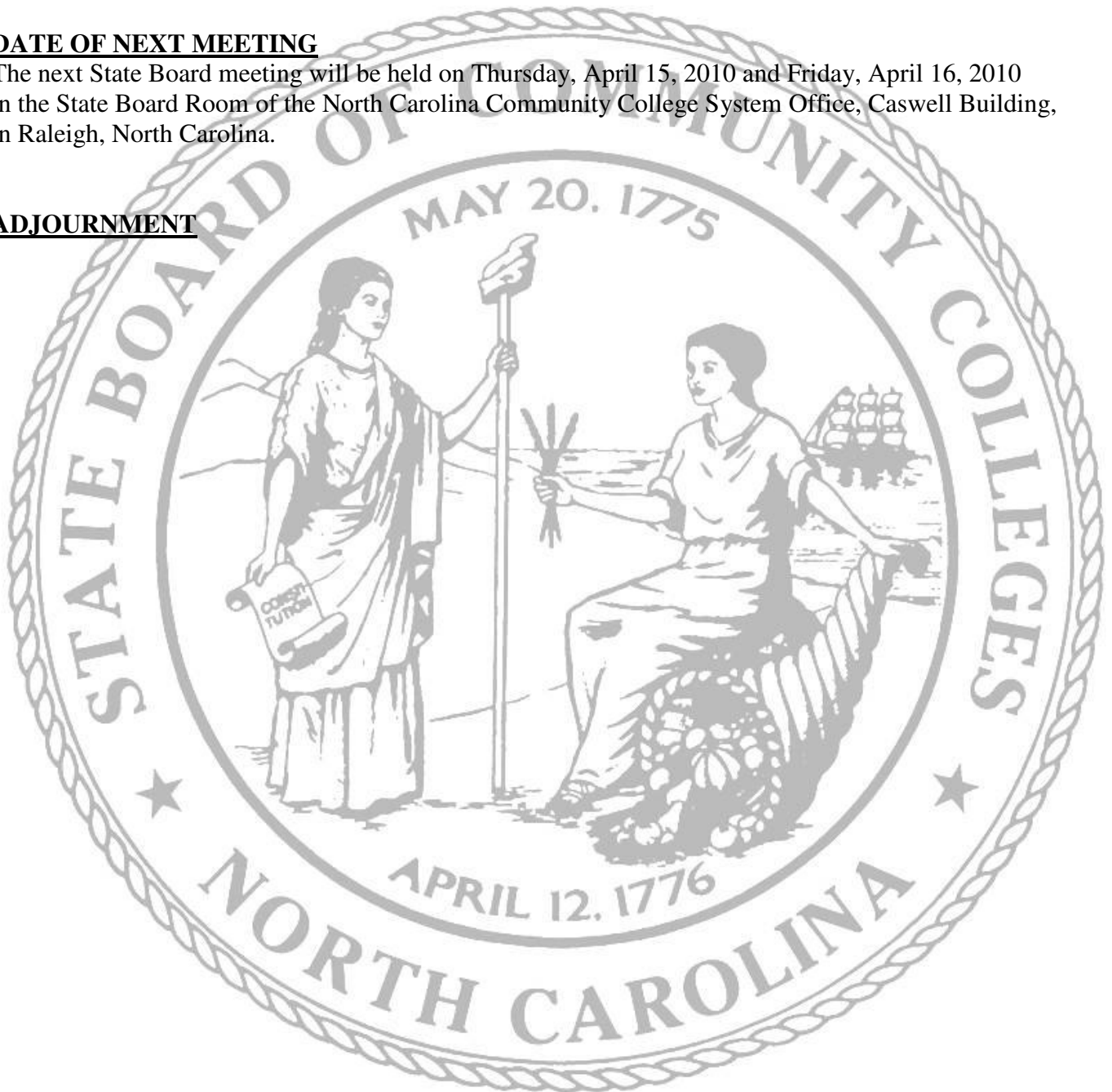
