Because of space limitations at the McKimmon Center, each college will be permitted to send only two participants. **We respectfully request that you serve as your college's registration coordinator** or identify one of your colleagues who could fulfill this responsibility. The registration coordinator will be responsible for identifying the two individuals at your institution who would benefit most from attending the conference and forwarding their completed registrations as outlined in the attached registration form.

Registration materials for the workshop are included with this memorandum for you to copy and distribute to others at your institution as you deem appropriate. Because the registration date is fast approaching, we will also notify others at your college that VPs/Deans of Student Services have been asked to coordinate registration for the event and encourage them to seek additional information from your office.
