CFNC COLLEGE REDIRECTION MODULE

The CFNC College Redirection Module is now available for Community College Admission Officers to utilize during the period of April 1 through August 31, 2009. The module can connect applicants with North Carolina colleges and universities which still have open admission slots. This module serves as a great prospecting opportunity for community colleges. We are encouraging all community colleges to take advantage of this opportunity to recruit applicants who may not otherwise be able to attend their first choice of colleges.

The goal is for every student in the college redirection pool to be contacted by their local North Carolina Community College. In five years, over 3,000 students have participated in the College Redirection Pool.

Interviews will be held **Saturday, May 2nd**, at 10:00 am in Raleigh at the NC Community College System office. This meeting will also serve as a transitional meeting for incoming board members.

Each candidate must have the following documentation in order to be interviewed:

- An official letter or transcript from their school's registrar to verify they have at least a 2.5 GPA.
- A signed recommendation letter from their SGA advisor/dean stating that they are in good standing at their local institution. This letter must also state that the local institution will support the student financially for all N4CSGA related expenses.
- A letter of intent from the student stating why they decided to apply for the position.

During the interview, each candidate will be required to present a 5 minute presentation to clarify/support their goals and motivation for the position in which they seek. If selected, they must also be available to attend the N4CSGA's mandatory Executive Bonding Retreat at Peace College in Raleigh through July 19-22nd, 2009.

DISABILITY SERVICES

Due to the recent budget directives, there have been questions regarding payment and contracts for accommodations for students with disabilities. According to Jennifer Haygood, NCCCS Vice President & Chief Financial Officer, "Colleges may continue to pay for existing personal contracts. The college must seek an exception from the Office of State Budget and Management (OSBM) to enter into a new contract or renew a contract. The justification that is submitted for such an exception should clearly indicate that the service is federally mandated."

MINORITY MALE MENTORING SUMMIT

The NCCCS hosted a successful Minority Male Mentoring (3M) Program Coordinators' Summit via Illuminate webinar on Wednesday, April 22 and Thursday, April 23, 2009. This mode of interaction will be considered when planning future meetings.

Topics covered during the Summit focused on challenges of the program due to budget restrictions, program practices, sustainability of the programs, and reporting. Coordinators expressed a desire to create supporting documents that could be used to obtain funding and gain additional support for the 3M Program.

CFNC STUDENT TRANSFER NAVIGATOR™ NOW AVAILABLE

Transfer Navigator™ provides a course by course equivalence report for courses that students have taken or plan to take in the future. Students may compare course equivalencies for two institutions at a time in three steps. Currently, transfer course information is only available for courses transferred from the 58 North Carolina Community College Campuses to the 16 University of North Carolina constituent institutions. NEW RACE AND ETHNICITY CODES

In October of 2007 the Department of Education issued its final guidelines on collecting, maintaining and reporting racial and ethnic data to the Department of Education. Beginning in 2010 institutions must use a new two-question format to collect race and ethnicity information from faculty, staff and students. This federally mandated project will provide 64 potential categories for students, faculty and staff to identify their race and ethnicity. One major difference is that individuals are now allowed to enter the data based on the group that they most closely identify with, which may be different from their ethnographic race and ethnicity.

Colleges should be able to collect this information using the new codes beginning this summer. The CFNC admissions application is also being modified to collect race and ethnicity information using the new format. More information can be found at:
