1.	Page 4, lines 20-21 and Page 5, lines 1-4.	Martin CC	The commenter recommended adding the township of Windsor to Martin CC's service area. The commenter referenced a special provision listed in the <i>NCCCS Fact Book</i> and Section 18 of the <i>NCCCS Curriculum Procedures Reference Manual</i> . The special provision provides that "[i]n the case of offering courses within the town or township of Windsor, Martin CC has exclusive authority for offering curriculum and adult basic education courses and both Martin CC and Roanoke-Chowan CC are authorized to offer other continuing education courses."	<b>MODIFICATION REQUESTED</b> – The System Office's recommendation is to add the township of Windsor to Martin CC's service area and to Roanoke-Chowan CC's service area for continuing education courses only. The System Office has notified both Martin CC and Roanoke-Chowan of its recommendation.

**1A SBCCC 200.1 Mission of the Community College System**

The mission of the North Carolina Community College System is to open the door to high quality, accessible educational opportunities that minimize barriers to post-secondary education, maximize student success, and improve the lives and well being of individuals by providing:

- (1)(a) education, training and retraining for the workforce, including basic skills and literacy education, occupational and pre-baccalaureate programs;
- (2)(b) support for economic development through services to and in partnership with business and industry; and
- (3)(c) services to communities and individuals which improve the quality of life.

**1A SBCCC 200.2 State Planning**

The State Board shall review the priorities of the system and adopt a system-level plan on at least a biennial basis, coordinated with the budget cycle. The plan shall take into account the current and future needs of the system and clarify the priorities essential to carrying out the mission of the system.

6 **SUBCHAPTER 300. COLLEGE SERVICE AREAS**

7  
8 **1A SBCCC 300.1 Definitions**

9 The following definitions apply to this Subchapter:

- 10 (a) Service Area: The geographic area to which the State Board of Community Colleges  
11 has assigned community colleges the authority and responsibility to provide education  
12 and training services for constituents within that geographic area.
- 13 (b) Home college: The community college located in the service area in which the military  
14 installation is based.

- 20 (a) The State Board shall assign service areas to colleges for providing education and  
21 training services. The initial assignment of service areas to colleges shall take into  
22 account the past and present patterns of providing services, including existing  
23 agreements between colleges. The State Board may reassign a service area upon  
24 the recommendation of the System President. The recommendation shall be based  
25 upon an analysis of the service areas involved, including consultation with the  
26 presidents of the colleges and the county commissioners of the county(ies) that are  
27 affected.
- 28 (b) A college may offer education and training in an area assigned to another college  
29 using criteria set forth in ~~1A SBCCC 300.99; 1D SBCCC 300.97;~~ 1D SBCCC 300.6  
30 and 1D SBCCC 400.96.

1 (c) The State Board of Community Colleges shall review, at least every five years, service  
2 areas that include counties assigned to more than one community college to  
3 determine the feasibility of continuing to assign those counties to more than one  
4 community college. The State Board shall revise service areas as needed to ensure  
5 that counties are served effectively. The first review and any revisions shall be  
6 completed no later than March 1, 2016, and the State Board shall report its findings  
7 and any revisions to the Joint Legislative Education Oversight Committee no later than  
8 March 1, 2016. All subsequent reviews and revisions shall also be submitted to the  
9 Joint Legislative Education Oversight Committee.

28 Educational programs offered by community colleges of the community college system  
29 of North Carolina on all military installations will be conducted by the home college. The  
30 home college is defined as that college located in the administrative area in which the  
31 military installation is based.—The home college by written agreement may contract with

1 another college within the community college system to provide any additional  
2 educational services which may be required by the military installation located in the home  
3 college's area. When contracting with other colleges to provide additional educational  
4 services to military installations, home colleges shall give priority ~~Priority will be given to~~  
5 ~~adjacent colleges~~ adjacent to the military installation to be served.
