

STATE BOARD OF COMMUNITY COLLEGES

Curriculum Program Terminations
As Approved by the System President

1D SBCCC 400.95(b) states the following:

The college shall terminate a curriculum program when there has been no enrollment for two years; a college may request an one-year extension of a curriculum program upon justification of the potential for employment opportunities and student enrollment.

On April 17, 2015, the System Office sent a letter to fifty-five colleges to notify them of programs that had not demonstrated enrollment in over two years. The letter requested that they either send in a program termination request or provide justification and a request for an extension. The majority of the terminations below resulted from this request.

The System President has approved the terminations as listed below:

Beaufort County Community College

Health and Fitness Science (A45630)

Rationale: Low Enrollment: There was limited student interest due to insufficient employment opportunities for graduates of the program within the college's service area.
Termination Semester: **Fall 2015**

Durham Technical Community College

Collision Repair and Refinishing Technology (A60130)

Rationale: No enrollment for two or more years. The college never implemented the program due to limited space.
Termination Semester: **Fall 2015**

Johnston Community College

Associate in Fine Arts (A10200)

Rationale: No enrollment for two or more years. The revisions made to the Associate in Arts (AA) degree in 2014 made the Associate in Arts program a more appropriate choice for the college's students.
Termination Semester: **Fall 2015**

Culinary Arts (A55150)

Rationale: No enrollment for two or more years. The program was ended due to low student enrollment and high costs.
Termination Semester: **Fall 2015**

Esthetics Instructor (Certificate) (C55270)

Rationale: No enrollment for two or more years. The Esthetics Instructor program was never activated due to low enrollment in the Esthetics program itself.
Termination Semester: **Fall 2015**

Interventional Cardiac & Vascular Technology (A45410)

Rationale: No enrollment for two or more years. Student interest was insufficient to sustain the high cost program. The college is able to provide the instruction through continuing education.
Termination Semester: **Fall 2015**

Montgomery Community College

Collision Repair and Refinishing Technology (A60130)

Rationale: No enrollment for two or more years. Facility upgrades required to provide current instruction became too cost prohibitive.

Termination Semester: **Fall 2015**

General Occupational Technology (A55280)

Rationale: No enrollment for two or more years. Students are now enrolled in the Associate in Arts or Associate in Science programs.

Termination Semester: **Fall 2015**

School-Age Care (Certificate) (C55450)

Rationale: No enrollment for two or more years. Students are enrolling in other programs including Early Childhood Education (A55220), Infant and Toddler Certificate (C55290), and Lateral Entry Certificate (C55430).

Termination Semester: **Fall 2015**

Southwestern Community College

Building Construction Technology (A35140)

Rationale: No enrollment for two or more years. The college experienced a decline in enrollment in the program due to the economic downturn.

Termination Semester: **Spring 2016**

Cosmetology Instructor (Certificate) (C55160)

Rationale: No enrollment for two or more years. There was a lack of student interest in the program has been due to limited employment opportunities in the college's service area.

Termination Semester: **Spring 2016**

Criminal Justice Technology/Latent Evidence (A5518A)

Rationale: No enrollment. There was a lack of student interest based on limited job prospects for graduates.

Termination Semester: **Spring 2016**

Esthetics Technology (Certificate) (C55230)

Rationale: No enrollment for two or more years. Students are currently enrolled in the college's Cosmetology program, which includes an esthetics component.

Termination Semester: **Spring 2016**

Gaming Management (A25250)

Rationale: No Enrollment for two or more years: There were insufficient employment opportunities for graduates in the service area. The program content has been consolidated into continuing education.

Termination Semester: **Spring 2016**

General Occupational Technology (A55280)

Rationale: No enrollment for two or more years. This program was historically used for pre-health science students completing admission requirements for selective health science programs. Those students have been transitioned to the Therapeutic and Diagnostic diploma programs.

Southwestern Community College (continued)

Hospitality Management (A25110)

Rationale: No enrollment for two or more years. Local employers have indicated that a short-term occupational certificate through continuing education is what is sufficient.

Manicuring Instructor (Certificate) (C55380)

Rationale: No enrollment for two or more years Lack of student interest in the program has been due to limited employment opportunities in the college's service area.

Termination Semester: **Spring 2016**

Masonry (Diploma) (D35280)

Rationale: No enrollment for two or more years. The college experienced a decline in enrollment in the program due to the economic downturn.

Termination Semester: **Spring 2016**

Medical Transcription (Diploma) (D25320)

Rationale: No enrollment for two or more years: There were insufficient employment opportunities for graduates in the service area. The program content has been consolidated into the Medical Office Administration (A25310) program.

Termination Semester: **Spring 2016**

Office Administration/Legal (A2537A)

Rationale: No Enrollment for two or more years: There were insufficient employment opportunities for graduates in the service area. The program content has been consolidated into the Office Administration (A25370) program.

Termination Semester: **Spring 2016**

Office Administration/Virtual Office Assistance (A2537B)

Rationale: No Enrollment for two or more years: There were insufficient employment opportunities for graduates in the service area. The program content has been consolidated into the Office Administration (A25370) program.

Plumbing (Diploma) (D35300)

Rationale: No enrollment for two or more years. The college experienced a decline in enrollment in the program due to the economic downturn

Termination Semester: **Spring 2016**

Real Estate (A25400)

Rationale: No Enrollment for two or more years: There were insufficient employment opportunities for graduates in the service area. The college will offer real estate instruction through continuing education if there is a need for it in the future.

Termination Semester: **Spring 2016**

Real Estate Licensing (Certificate) (C25480)

Rationale: No Enrollment for two or more years: There were insufficient employment opportunities for graduates in the service area. The college will offer real estate instruction through continuing education if there is a need for it in the future.

Termination Semester: **Spring 2016**

Tri-County Community College

Building Construction Technology (A35140)

Rationale: No enrollment for two or more years. The program was no longer sustainable due to a severe downturn in the local building industry.

Termination Semester: **Fall 2016**

Esthetics Instructor (Certificate) (C55270)

Rationale: No enrollment for two or more years. Lack of student interest in the program due to limited employment opportunities in the college's service area.

Termination Semester: **Fall 2015**

Healthcare Management Technology (A25200)

Rationale: No Enrollment for two or more years: There were insufficient employment opportunities for graduates in the service area. The program content has been consolidated into the Office Administration (A25370) and Medical Office Administration (A25310) programs.

Termination Semester: **Fall 2015**

Networking Technology (A25340)

Rationale: No Enrollment for two or more years: There were insufficient employment opportunities for graduates in the service area. The program content has been consolidated into the Computer Information Technology (A25260) program.

Termination Semester: **Fall 2015**

Real Estate Licensing (Certificate) (C25480)

Rationale: No Enrollment for two or more years: There were insufficient employment opportunities for graduates in the service area. The college will offer real estate instruction through continuing education if there is a need for it in the future.

Termination Semester: **Fall 2015**

Wilson Community College

Alternative Transportation Technology (D60420)

Rationale: No enrollment. The college anticipated a need to offer the program but did not have sufficient demand.

Termination Semester: **Fall 2015**

Lateral Entry (Certificate) (C55430)

Rationale: No enrollment for two or more years. Students needing lateral entry courses generally need one through three courses to meet the teacher certification requirements for the state. Therefore, they do not need all the courses in the certificate and do not enroll in the program. These students take the courses they need as special credit students.

Termination Semester: **Fall 2015**

Manufacturing Technology (A50320)

Rationale: No enrollment for two or more years. There has been no demand for the program due to the economic downturn.

Termination Semester: **Fall 2015**

School-Age Care (Certificate) (C55450)

Rationale: No enrollment for two or more years. Students are not enrolling in the certificate due to the reduction in available teacher assistant positions.
