1.	Page 7, line 29 to Page 8, line 9	Richmond CC	The commenter recommended rebranding the HRD courses. The name “HRD” causes great confusion with students and employers since HR is perceived by everyone else as being related to personnel. The college has stopped using HRD as an external label, and the college describes these courses as “Pre-Employment programs.” The commenter recommended changing the name of “HRD courses to either “Pre-Employment” or “Employability Skills” to better describe this set of courses.	NO MODIFICATION AT THIS TIME – The System Office believes that this change should be vetted through the Presidents’ Association for their thoughts on this change. To avoid stifling the implementation of the entire Chapter for consideration of this change, the System Office recommends leaving the language as is for now. The System Office will seek to get the Presidents’ consensus on this recommendation going forward.
2.	Page 9, lines 23-24; Page 9, lines 27-28; and Page 9; line 30 to Page 10, line 2.	Sampson CC	Why does the proposed amendment not include a description of self-supporting classes except as it pertains to underage students taking classes during the summer months? Also, the Community Service classes do not earn budget FTE. The commenter wanted the rules changed enabling colleges to earn FTE through Community Service offerings.	NO MODIFICATION - Self-support is a funding method and the rules around continuing education course sections funded as self-support are located in 1E Subchapter 600 – “Self-Supporting Course Sections.” Community Service programs are for personal enrichment and recreation. While an important component of a college’s relationship with its community, these courses are not eligible for state supported funds intended to support 115D-1 and are specifically excluded from receiving funds

Page 9, lines 27-28	System Office		<p>MODIFICATION REQUESTED: Page 9, lines 25 and 29 include language such as “minor(s) less than 16 years old.” However, Page 9, line 27 does not include an age for a minor. The System Office recommendation is to amend 1D SBCCC 300.4(c)(2)(A) to read “Minors less than age 16 may enroll in self-supporting safe driving course sections during any reporting term” so that it is clear that the rule applies to minors who are less than age 16.</p>

8 **1D SBCCC 300.1 Definitions**

- 9 (a) “Continuing Education” – Continuing Education programs provide education and training
10 opportunities for targeted audiences. Courses are non-credit, short-term, and are offered in a
11 variety of instructional delivery modes and locations. For the purpose of this subchapter,
12 “Continuing Education” refers to the following programs: Workforce Continuing Education
13 Training, Human Resources Development, and Community Service.
- 14 (b) “Course” – Refers to the list of approved courses in the Combined Course Library maintained
15 by the North Carolina Community College System Office.
- 16 (c) “Class” - An individual course section or unit of instruction with a specific date and time
17 duration.
- 18 (d) “Register” – To complete the procedure defined by the college to sign up for a course section

23 **1D SBCCC 300.2 Registration**

- 24 (a) Registration. Each college shall maintain an open-door registration process for individuals
25 who are either high school graduates or are at least 18 years of age. Officials of each college
26 shall make student registration determinations.
- 27 (1) Safety Exceptions. Boards of trustees may adopt policies refusing registration to any
28 individual if it is necessary to protect the health or safety of the individual or other
29 individuals. When making a health and safety determination, colleges may refuse
30 registration to an applicant when there is an articulable, imminent, and significant threat to

1 the individual or other individuals. Colleges refusing registration on the basis of a health
2 or safety threat shall document the following:

- 3 (A) Detailed facts supporting the rationale for denying registration;
4 (B) The time period within which the refusal to register shall be applicable and the
5 supporting rationale for the designated time period; and
6 (C) The conditions upon which the individual who is refused registration would be
7 eligible to be registered.

16 ~~(a) A curriculum program is an organized sequence of courses leading to an~~
17 ~~associate degree, a diploma, or a certificate. All curriculum programs are~~
18 ~~designed to provide education, training, or retraining for the work force.~~

19 ~~(i) Associate degree programs are planned programs of study~~
20 ~~culminating in an associate in applied science, associate in arts,~~
21 ~~associate in fine arts, associate in science, or associate in general~~
22 ~~education degree.~~

23 ~~(A) The associate in applied science degree programs are~~
24 ~~designed to prepare individuals for employment. These~~
25 ~~programs involve the application of scientific principles in~~
26 ~~research, design, development, production, distribution, or~~
27 ~~service.~~

28 ~~(B) The associate in arts, associate in science, and associate in~~
29 ~~fine arts degree programs are designed to prepare students~~

25 ~~(a) Occupational Extension courses consist of single courses, each complete in~~
26 ~~itself, designed for the specific purposes of training an individual for full-~~
27 ~~or part-time employment, upgrading the skills of persons presently~~
28 ~~employed, and retraining others for new employment in occupational fields.~~

29 ~~(b) Community Service:~~

1 (i) ~~Community Service courses consist of single courses, each~~
2 ~~complete in itself, that focus on an individual's personal or leisure~~
3 ~~needs rather than occupational or professional employment.~~

4 (ii) ~~The cultural and civic, and visiting artist component of this program~~
5 ~~meets community needs through lecture and concert series, art~~
6 ~~shows, the use of college facilities by community groups, providing~~
7 ~~speakers to community organizations, and providing visiting artist~~
8 ~~activities for college communities. Visiting artists may be provided~~
9 ~~an opportunity to work as artists in residence to enhance local arts~~
10 ~~resources and promote the various visual, performing and literary~~
11 ~~arts in communities throughout North Carolina.~~

12 (e) ~~Self Supporting Programs:~~

13 (i) ~~A self-supporting course is not reported to the state for budget FTE~~
14 ~~since the cost of conducting the course is paid by students enrolled.~~

15 (ii) ~~Recreational programs are self-supporting courses which the college~~
16 ~~may provide at the request of the community but for which the~~
17 ~~college receives no budgetary credit. Funds appropriated as~~
18 ~~operating expenses for allocation to the colleges shall not be used to~~
19 ~~support recreation courses. The financing of these courses by a~~
20 ~~college shall be on a self-supporting basis, and membership hours~~
21 ~~produced from these activities shall not be counted when computing~~
22 ~~full time equivalent students for use in budget funding formulas at~~

24 (d) ~~Basic Skills Programs. The State Board and the community college system~~

1 ~~(iv) — The English as a Second Language (ESL) program offers classes~~
2 ~~which accommodate the varied needs of the immigrant and refugee~~

5 ~~appropriate communication skills and upon the student's ability to~~
6 ~~function in the adult American community. Classes are offered at~~
7 ~~the beginning through the advanced levels of ESL. The curriculum~~
8 ~~is designed to develop the basic language skills of reading, writing,~~
9 ~~speaking, and listening. Instruction integrates the English language~~

12 ~~(v) — The Compensatory Education (CED) program is designed for adults~~

 23 (a) Workforce Continuing Education Training. Workforce Continuing Education Training
 24 programs are designed to provide instructional opportunities for individuals seeking to gain
 25 new or upgrade current job-related skills. Programs can be delivered as a single course or
 26 bundled as a series of courses that provide instruction around skill competencies that lead to a
 27 recognized credential (licensure, certification, renewal, registry listing) or meets local
 28 workforce labor needs.
 29 (b) Human Resources Development. The Human Resources Development (HRD) program
 30 provides skill assessment services, employability skills training, and career development
 31 counseling to unemployed and underemployed adults. Each college shall operate a Human

1 Resources Development (HRD) program to provide assessment services, employability
2 training, and career development counseling to unemployed and underemployed individuals.

3 These courses shall address six core components:

4 (1) Assessment of an individual's assets and limitations;

5 (2) Development of a positive self-concept;

6 (3) Development of employability skills;

7 (4) Development of communication skills;

8 (5) Development of problem-solving skills; and

9 (6) Awareness of the impact of information technology in the workplace.

10 (c) Community Service. Community Service programs provide courses, seminars, and community
11 activities that contribute to an individual's cultural, civic, and personal growth.

17 (a) Program Accountability.

18 (1) Each college's local board of trustees shall adopt a Continuing Education Internal Program
19 Accountability Plan. At a minimum, the Continuing Education Internal Program
20 Accountability Plan shall define a system of checks and balances to prevent and detect
21 errors or irregularities when reporting hours for FTE purposes and establish a framework
22 for defining program quality and improvement procedures.

23 (2) The local board of trustees shall review the Continuing Education Internal Program
24 Accountability Plan at least once every three years from the date the local board of trustees
25 adopts the Continuing Education Internal Program Accountability Plan.

26 (3) A copy of the Continuing Education Internal Program Accountability Plan, including
27 amendments, shall be submitted to the Continuing Education Department at the System
28 Office upon adoption.

29 (b) Faculty. Colleges shall employ faculty so as to meet Southern Association of Colleges and
30 Schools' criteria and local college policies. All faculty providing instruction in programs with

1 external agency oversight must be a qualified instructor as established by the respective
2 agency or certifying entity.

3 (c) Services to Minors. For the purposes of this subsection, the word “minor” shall not include
4 minors who have graduated from high school. The major purpose of community colleges is to
5 serve students who have graduated from high school, have obtained a high school equivalency
6 diploma, or are beyond the compulsory age limit of the public school and have left public
7 school. However, a minor may enroll in Continuing Education course sections subject to the
8 following:

9 (1) Minors Age 16 and 17. A minor, age 16 or 17, may enroll in Continuing Education course
10 sections subject to the following conditions:

11 (A) Minors shall not displace adults.

12 (B) Minors shall pay the registration fees associated with the course section except for cases
13 where they meet eligibility requirements for a fee waiver.

14 (C) If the minor is enrolled in high school, the following restrictions apply:

15 (i) Colleges shall not designate Continuing Education course sections taken by the
16 high school student to provide partial or full credit towards meeting high school
17 graduation requirements.

18 (ii) Colleges shall not offer Continuing Education course sections that are specifically
19 scheduled for high school students except:

20 (I) Continuing Education course sections that maintain 90% (ninety percent) of
21 instructional hours within the summer reporting term as defined in 1G SBCCC
22 200.99(a)(1)(B).

23 (II) Self-supporting safe driving courses which may be provided during any
24 reporting term.

25 (2) Minors Less than Age 16. A minor less than 16 years old may enroll in Continuing
26 Education course sections subject to the following conditions:

27 (A) Minors may enroll in self-supporting safe driving course sections during any reporting
28 term.

29 (B) A college may provide classes for minors less than 16 years old only during the summer
30 reporting term. These classes must be self-supporting and may not be designated by the

1 college to provide partial or full credit towards meeting high school graduation
2 requirements.

3 (d) Juvenile Justice. Colleges may provide Continuing Education course sections to juveniles of
4 any age who are committed to the Division of Juvenile Justice of the Department of Public
5 Safety, if the juvenile is otherwise qualified for registration in the Continuing Education class
6 and has the approval of the Director of the Youth Development Center to which the juvenile
7 is assigned.

8 (e) Once enrolled, minors shall be treated the same as all other students.

13 **1D SBCCC 300.5 Course Standards**

14 (a) Master Course Schedule. Colleges shall maintain a master schedule, including days, time,
15 and location for all Continuing Education class offerings, including the physical address to
16 off-campus class locations.

17 (b) Course Approval Process. The provisions for the course approval process for Continuing
18 Education courses follow:

19 (1) Colleges seeking to add a new course to the Combined Course Library or seeking to modify
20 an existing course shall submit a new course or modification request to the North Carolina
21 Community College System Office. The North Carolina Community College System
22 Office shall maintain new course or modification request forms and guidance documents
23 and make them available to colleges upon request.

24 (2) The Continuing Education Leadership Committee, comprised of a rotating slate of
25 Continuing Education senior administrators from local colleges, will review all requests
26 for new courses or course modifications. The Continuing Education Leadership
27 Committee shall recommend approval of the new course or approval of the modification if
28 all of the following conditions are met.

29 (A) All requests for new courses and course modifications must meet the definition of
30 continuing education as defined in 1D SBCCC 300.1(a).

1 (B) All requests for new courses and course modifications must demonstrate workforce
2 need with local and state labor market data.

3 (C) New course requests shall not duplicate the scope of the description of existing
4 Combined Course Library courses.

5 For requests that comply with 1D SBCCC 300.5(b)(2)(A)–(C), the Continuing Education
6 Leadership Committee shall submit its recommendation to the Workforce Continuing
7 Education staff at the North Carolina Community College System Office with a copy to
8 the requesting college, and the Workforce Continuing Education staff shall submit the
9 recommendation to the State Board of Community Colleges for final approval.

10 (3) Once a course is approved and placed in the Combined Course Library, colleges do not
11 have to seek additional approval from the North Carolina Community College System
12 Office to offer the course as long as the course meets the standards set forth in this
13 Subchapter.

14 (c) Course Standards. All Continuing Education course sections shall be based on courses
15 maintained in the Combined Course Library. The course standards for Continuing Education
16 local course offerings follow:

17 (1) Course Title. A college may use a local course title to clarify the instructional content,
18 instructional methodology, and target audience.

19 (2) Course Description. A college may use a local course description to clarify the instructional
20 content, instructional methodology, and target audience as long as the content of the course
21 falls within the scope of the State Board approved course description listed in the
22 Combined Course Library.

23 (3) Scheduled Hours. Colleges shall not schedule hours that exceed the maximum approved
24 hours for instruction for the specific course within the Combined Course Library.

25 (d) Continuing Education Units. One Continuing Education Unit (CEU) is equal to ten contact
26 hours of participation in class.

27 (e) Course Articulation. In accordance with criteria set forth by the Southern Association of
28 Colleges and Schools Commission on Colleges (SACSCOC) and local college policies, a
29 college may award academic credit for course work taken on a noncredit basis only when there
30 is documentation that the noncredit course work is equivalent to a college designated credit
31 experience as determined by the college.

A minor, 16 years old or older, who is not currently enrolled in a public or private educational agency may be admitted to a Basic Skills or Continuing Education program at a college if a North Carolina local public or private educational agency, where the minor now resides, determines that admission to a Basic Skills or Continuing Education program is the best educational option for the student and the admission of the student to a Basic Skills or Continuing Education program is approved by the college under one of the following conditions:~~
